If you are accessing the Postgraduate Loan or self-funding your tuition fees there are some key dates and T&C's which you need to know.

Tuition fee cost

If you are starting in **May 2025** the tuition fee is £8,500 for the full course.

Full-time student's payment plan

Throughout the academic year (May 2025 – May 2026) you will have to pay the full tuition fee, the payment deadlines split the tuition fee into three instalments (£2,840.00, £2,830.00 & £2,830.00).

Tuition fee payment deadlines for students starting in May 2025:

Full-time (12 Months)

First Instalment: 12th May 2025 (£2,830.00)

Second Instalment: 15th September 2025 (£2,830.00)

Third Instalment: 19th January 2026 (£2,830.00)

Part-time student's payment plan

Throughout the academic year (May 2024- May 2026) you will have to pay the full tuition fee, the payment deadlines split the tuition fee into six instalments (Year 1 - £1,415, £1,415, £1,420, Year 2 - £1,415, £1,415, £1,420). Fee payment deadlines for students starting May 2024:

Part-time (24 Months)

First Instalment: 12th May 2025 (£1,415)

Second Instalment: 15th September 2025 (£1,415)

Third Instalment: 19th January 2026 (£1,420)

Fourth Instalment: 11th May 2026 (£1,415)

Fifth Instalment: 14th September 2026 (£1,415)

Sixth Instalment: 18th January 2027 (£1,420)

How to pay your fees

Your tuition fees are paid through a recurring card payment plan, please refer to your "ARUL Postgraduate Tuition Fee Payment Plan" for payment details. This payment plan must be completed and signed to formally complete registration onto the course. Cancelling this agreement will be taken as a withdrawal request from your course of study.

Withdrawal tuition fee liability

Full-time students

The amount of tuition fee owed will depend on when the official withdrawal date from ARU London was processed. Any student who withdraws on or before 05th October 2025 will be liable to pay 33% of the total tuition fee. If a student is still registered on the 06th October 2025 and then proceeds to withdraw on or before 01st February 2026 they will be liable to pay 66% of the total tuition fee. If a withdrawal is processed on or after 02nd February 2026 the student will be liable to pay 100% of the tuition fee for that academic year.

Part-time students

The amount of tuition fee owed will depend on when the official withdrawal date from ARU London was processed. Any student who withdraws on or before 30th May 2026 will be liable to pay 50% of the total tuition fee. If a withdrawal is processed on or after 31st May 2026 the student will be liable to pay 100% of the total tuition fee.
